- **3. Treasurer Report: Jeff-** We have an increase in revenue but profits were down due to an increase in instructor fees. We have also done lots of fundraising this year to help contribute to the Fitness Trail. We received a donation from Conviction Fitness of \$3500 to be used for the Fitness Trail. - Jeff: **Motion to waive the yearly audit**: Explanation that this type of audit is expensive and we waive it because we use an accountant to do our books. We also don't raise enough money to pay for the audit. Second, Megan- **Carried.**
- **4.** Chairperson Report: Daren -See attached. There is one change to this report. The Murphy Park Fitness Trail project was originally planned to be installed on City property. After submitting a more detailed plan to the City, the city provided us with detailed instructions and requirements to install the equipment. After studying those requirements it was decided that those requirements would cause considerably more cost to the project. It was decided that we would explore another avenue to be determined very shortly.
- **5. Facilities: Valerie-** McLurg School has decided that there are using Thursday evening for school use so it is no longer available to use. We are now booking of Friday evening instead. Also, the deposit for school keys has rose to \$100, apparently some groups were not returning keys in a timely fashion so the deposit was raised.
- **6. Programs: Megan-** We are scheduling 15 programs to run, depending on enrollment, and there are five new ones. We have also raised the cost of each program by \$5, after comparing our prices to the CA's in the city. We have also adopted a new registration process and are trying out

an online registration as well. Hopefully this speeds up the process for everyone! The on line registration will available sometime this evening.
